1. Studio will begin approx. 1 1/2 hours before ceremony (if pre-ceremony segment is included); to continue at reception not to exceed 7 hours. Additional time will be billed at 75.00 per hour.
2. If the total job time exceeds four (4) hours, Studio must either be supplied food and non-alcoholic beverage(s) by Client, or Studio shall be permitted a time period not to exceed one (1) hour to leave and obtain refreshment. It is advisable at reception, for studio to be served after wedding party and before guests as to not miss any important shots. It is also advised that studio be served in same room as wedding party. Please contact reception facility and inform them of this arrangement.
3. Client agrees to cooperate fully with Studio and understands that without full cooperation by Client, satisfaction cannot be guaranteed. Video limitations with church rules must be determined before wedding date. Client understands that church limitations are out of studios control.
4. Studio has the right to assign any videographer(s) for this assignment.
5. It is understood that Studio is the exclusive official videographer, and others taking videos will be permitted only at our discretion.
6. In the event of a postponement or cancellation of this contract, the retainer fee paid may be used for any future event up to one year past the date of this contract providing Studio has no other obligations for the future date. After that time, all retainers will be forfeited to Studio.
7. Studio reserves the right to use the original video and/or reproductions for display, publication or other purposes.
8. Studio is sole decision maker in the shooting and editing process to create an artistic product for client.
9. Studio takes utmost care with respect to the exposure, editing, duplication and delivery of the video products and services offered. However, in the event the studio fails to comply with the terms of this contract due to any event or act outside of the control of the Studio, the Studio's liability is limited to the refund of the retainers.
10. Additional videos may be purchased @ \$40.00 per DVD. These videos will also be available after delivery of edited video.
11. Please notify photographer that a videographer will be present.
12. A non-refundable retainer fee of 1/3 of contract will be paid to reserve date. An additional non-refundable retainer of 1/3 \$ \_\_\_\_\_ is due (date)= \_\_\_\_\_ 30 days before wedding date. If second payment is not received by studio, the wedding will be treated as a cancellation. A final payment in the form of cash, money order, credit card, or cashier's check of 1/3 = \$ \_\_\_\_\_ is due before edited video is delivered.
13. \$50.00 will be charged for any returned checks and must be paid before delivery of video.
